 - Election reminder: educate yourself. There are some big races. Get out and vote
 - Trimester vs. Semester: We need to get the process going if we want to examine our current trimester system. The board responded by wanting to learn the pros and cons. Mr. Doornbos will form a committee to study this. Building the new schedule and transitioning will take a full year.
 - CGJSHS recognized as All-Star High School Status
 - Financial Update - A 3-year cost comparison shows utility/fuel costs to show the inflation trend.
 - K12itc arrived Friday and started with hardware replacement. The next step is device migration.
 - USD 417 was awarded three Kansas Can Stars: a Copper in Academically Prepared for Postsecondary (State Assessments), a Silver in Graduation Rate, and a Copper in Postsecondary Effectiveness.
